VSDCUA Annual Report 2021/22 Season - Umpire Recruitment & Relationships

Over the past season, our key method of recruiting and promoting our umpires and the competition was via Facebook providing multiple positive outcomes for our association. Highlighting the rich cricketing history of our umpires. Celebrated life memberships and fantastic milestones. Honour cricketing heroes from Subbies Clubs that had passed away. Promoting our magnificent game and inviting cricket-loving individuals to join our umpiring panel.

We celebrated the achievements of new life members Neill Murray, Michael Moore & John Doig and milestone matches of 300 1st Eleven games by Michael Wheelahan. We also looked back at the amazing career of Ian Aitken* (527 matches) passed by Brian Benny Goodman during the season and made a short video of our young gun Vas Shipp, the youngest VSDCA umpire, aged 19. We also did a post on Greg Rollo after he was selected to umpire the interstate match between Victoria & NSW in the Mid-Year Cricket Association.

Recruitment

We recruited a host of new umpires for season 21/22, and we were lucky enough to welcome back some great guys who re-joined the panel.

The pandemic certainly affected the cricket umpiring community with a massive downturn in umpire numbers across Victoria.

The lack of umpire numbers and the inclusion of four new clubs this season made it difficult for our Umpire Appointments Manager, Neill Murray, to place umpires at all games.

Out of these times, new ideas arose to look at a long-term solution to rectify the shortfall. A proposal has been put in front of Cricket Victoria that will help strengthen cricket umpiring from the bottom up and develop a pathway solution where all competitions can thrive.

Right now, we have a shortage of numbers and recruitment needs to be done by every member of our umpiring community. The \$100 incentive (backed by the VSDCA & VSDCUA) has been put in place to encourage our team, to recruit new cricket-loving individuals to take up umpiring to put back into the game. I encourage every member to support this initiative and not just leave it to myself.

I would also like to acknowledge both Neill Murray & Brian Goodman for the countless hours they put in every week to ensure our umpire team is ready to go each weekend.



J G CRAIG UNDER 15 COMPETITION (Formerly the R M Hatch Competition)

The VSDCA established the R M Hatch under 15 competition in 1969 as a vehicle for their promotion of cricket. The competition was named in honour of Ron Hatch, whose involvement with sub-district cricket spanned almost 60 years as Delegate, Secretary, and President for 27 years, and as Patron until his passing in 1987.

Season 2014-15 saw the name changed to honour the work and dedication of VSDCA stalwart John Craig.

Since 1972, the VSDCUA has presented a trophy to the best player in each section and since 1978 these presentations have been made at the Grand Final of the competition.

The Premiers in 2022 were Brunswick 5/131 defeating Ormond 130(cc).

The player of the match was D.Aitken for Brunswick who made 45 n/o, took 1/5 off 3 overs and took a spectacular catch.

Cricket is an exciting game that encourages leadership, friendship, and teamwork, which brings together people from different nationalities, cultures and religions, especially when played within the Spirit of Cricket.
