PRESIDENT'S REPORT

It gives me great pleasure to again submit my President's Report on behalf of the VSDCUA.

At the time of writing last years report we were several months into the Covid-19 Pandemic and very much unaware of what was before us.

As the year progressed, we continued to face the challenges that were placed in front of us daily.

Thoughts turned to whether we would have a cricket season in 2020/21 as winter Community Sport was cancelled.

As a Committee we had many phone calls and emails to discuss matters from an Umpires perspective.

Discussions with the VSDCA were also taking place regularly and ultimately we started to receive information from Cricket Victoria as a result of their ongoing consultation with the Government Health authorities and Victorian Sport and Recreation.

As this was received, through the VSDCA, we onforwarded the information to our membership.

Suffice to say as the days and weeks progressed there was some light at the end of the tunnel for Cricket and under strict Covid guidelines, after several adjustments to dates, a reduced 2020/21 season was announced and commenced in November 2020.

Compliments to the VSDCA Executive for their efforts in achieving this outcome and the ongoing liaison we had with them.

Covid restrictions also meant that we could not hold our normal meetings and thus one had to become accustomed to going online through Zoom which created some challenges for those not up with modern technology.

Our scheduled July AGM became a September Zoom AGM and the necessary business was conducted which saw myself re-elected President, Michael Moss (Secretary), Adam Devlin (VP), Warren Pump (Treasurer) and John Robinson and Colin Newport (Committee). One vacancy remained and was filled by Shiv Ranjit later in the season.

Mid-season Secretary Michael Moss resigned and Michael Payne was appointed by the Committee.

I sincerely thank Michael Moss for the effort and very efficient way he performed the Secretarial duties of the VSDCUA, the liaison with the membership, and the support he provided to me during his tenure.

We continued to conduct our meetings via Zoom during the season, with a few little hiccups, but we survived the challenges.

Dr Geoff Hart (VSDCA Deputy Board Chairman & Cricket Operations Manager) reported to the membership on behalf of the VSDCA.

Brian Goodman (Umpires Coach), Neill Murray (Umpires Appointment Manager) and John Doig (Manager Umpire Recruitment & Relationship) all contributed to our meetings.

These three gents are appointed by the VSDCA to these positions but are also Umpires from within our membership.

John has also done great work with interviews of Umpires who have reached significant milestones, and this has been placed on the VSDCUA Facebook pages and is widely read.

This is a great promotion for us as Umpires and the VSDCA.

With a season of one day matches the weather was kind and Duckworth Lewis was used sparingly.

Everyone should be congratulated on their efforts in these Covid times as a successful season of cricket was played in VSDCA. Well done.

At seasons end the Covid restrictions has eased sufficiently for us to hold our VSDCUA Pre Finals Dinner.

It was the previous year's Dinner, just prior to Covid regulations commencing, at which we last met in person so 12 months between drinks!

This year we ventured to a new venue at Sandy by the Bay, Beach Road Sandringham with views over the Bay and adjacent Trevor Barker Oval. A splendid 3 course meal and drinks provided by ASAT Catering made for a very good evening. I was very pleased that we had 60 acceptances and many of our Umpires travelled significant distances to attend.

The Matt Harris Award (Most Improved Umpire) was presented to Anubhav Sapra.

Adam Devlin, Graham Hill, Ray Stokes and Ian Wyatt received their 100 games medallion and bar.

Leo Collins received his 200-game bar and was also inducted into the VSDCUA 200 Club.

Gary Barr, Colin Newport and Bill Finnigan received 300 games and David DÁltera 400 games bars . Greg Rollo received a Certificate for 250 games.

Brian Goodman also received a special presentation from VSDCA Chairman Phil O'Meara in recognition of umpiring 400 1st XI games.

The VSDCA has recently changed the requirements to attain Life Membership being 300 1st XI games as an Umpire or 300 1^{st} XI games as a player or in total if played and umpired in 1^{st} XI.

Merv Hindson received Life Membership of VSDCA.

Matthew Raby, John Ryan and Michael Wheelahan have also received Life Membership.

I congratulate all on their achievements.

Our Umpiring numbers again increased this year and it has been pleasing to welcome so many new umpires.

With the proposed expansion of VSDCA we will still need more umpires to maintain our excellent coverage of games.

Two of our Umpires from last year's Academy intake continued to Umpire this season which was great to see. Covid this year meant that it was not possible to conduct the Academy with a new intake.

Our financial position remains strong because of a State Government Grant of \$3000, our ongoing Sponsorship from East Malvern Community Bank of \$3500, Icon Sportswear who provide our Umpire Polo and Match Day shirts \$500 and a contribution from VSDCA of \$2800 on behalf of Club Umpires.

This year due to Covid we reduced Membership fees to \$100 from \$150 but in viewing our budget I expect there will be some increase next season from the \$100.

Favourable comment continues to be received on our presentation in the current uniform and we are in the process of ordering more stock for next season.

Thank you to the many Umpires who travelled to collect apparel and to those members who acted as conduit in getting apparel delivered around the suburbs.

This year I attended the J G Craig finals to present the Trophies, donated by the VSDCUA, to Best Players in each Zone. It is great to see the response and smiles on their faces when they receive the Trophy.

Contact is regularly maintained with Ken Hilton and Phil O'Meara of VSDCA and the lines of communication are always open and very much appreciated.

Peter White remained Umpires Advocate this season to support Umpires should they be required to attend the Tribunal/Investigation Committee.

To my Committee members from this and previous years, whilst I have been President, I thank you for your outstanding work on behalf of the Association and membership. We have come a long way in the last 4 years and I look forward to watching the future progress of the VSDCUA as a member only.

To John Robinson who is also stepping down from the Committee thankyou for your tireless efforts over the many years you have been involved in various capacities.

To you all I trust you have enjoyed the season and thankyou for maintaining a high standard of Umpiring commensurate with the standing of the VSDCA in the world of cricket.

Thankyou for you support and friendship as we move forward.

As we are still in Covid-19 times stay safe and well.


Reviewer's Opinion

J G CRAIG UNDER 15 COMPETITION (F

(Formerly the R M Hatch Competition)

The VSDCA established the R M Hatch under 15 competition in 1969 as a vehicle for their promotion of cricket. The competition was named in honour of Ron Hatch, whose involvement with sub-district cricket spanned almost 60 years as Delegate, Secretary, and President for 27 years, and as Patron until his passing in 1987.

Season 2014-15 saw the name changed to honour the work and dedication of VSDCA stalwart John Craig.

Since 1972, the VSDCUA has presented a trophy to the best player in each section and since 1978 these presentations have been made at the Grand Final of the competition.

The Premiers in 2021 were Ormond which made an impressive 7/200(cc) defeating Plenty Valley being all out for 89 in the 36th over.

The player of the match was Jack Mannix who made 38no and took 3/17 with the ball.
